SUMMARY

GENERAL TERMS AND CONDITIONS FOR PARTICIPANTS TO G31000

1.- Registration fees. All participants must pay the registration fee prior to arrival at the course venue.

2.- Cancellation Policy. Registration cancellations must be notified via email to G31000 at Email: cancellations@G31000.org. Substitutions are welcome any time. Cancellations received 60 working days prior the first day of the course will receive a refund of registration fees less an administration charge of 10% of the Course fee. Cancellations received between 60 and 30 working days prior the first day of the course will receive a refund of 50% of the course fee.
