SUMMARY

GENERAL TERMS AND CONDITIONS FOR PARTICIPANTS TO G31000

1.- Registration fees. All participants must pay the registration fee prior to arrival at the course venue.

2.- Cancellation Policy. Registration cancellations must be notified via email to G31000 at Email: cancellations@G31000.org. Substitutions are welcome any time. Cancellations received 60 working days prior the first day of the course will receive a refund of registration fees less an administration charge of 10% of the Course fee. Cancellations received between 60 and 30 working days prior the first day of the course will receive a refund of 50% of the course fee. Cancellations made after, as well as 'no shows', are liable for the full course fee but will receive the course pack and online access to all the course materials.
