## SUMMARY

In this intensive three days course, participants develop competence in the foundations of the ISO 31000:2018 risk management standard. Based on in-depth teaching, practical exercises and quiz questions that test their aptitude, participants acquire the necessary knowledge and skills to pass the stringent exam. They do so by becoming familiar with the vocabulary, principles, framework and the risk management process proposed in the ISO 31000:2018 standard.





During the course, we will present the ISO 31000 Risk Management Principles and Guidelines and its two companions, the ISO Guide 73:2009, and the IEC/ISO 31010:2019 Risk Assessment Techniques.
