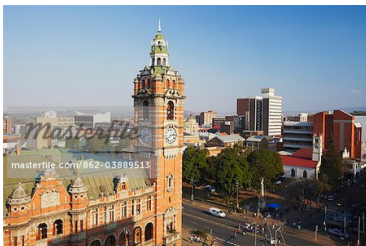
## ABOUT THE TRAINER
