1.- Registration fees. All participants must pay the registration fee prior to arrival at the course venue.

Cancellations received 60 working days prior the first day of the course will receive a refund of registration fees less an administration charge of 10% of the Course fee. Cancellations received between 60 and 30 working days prior the first day of the course will receive a refund of 50% of the course fee.
