SUMMARY

This course enables participants to become certified risk management professionals (Foundations level). The training and exam are based on the ISO 31000:2018 risk management standard which can be used by organizations of any size, any industry, and for any types of risk.

In this intensive course, participants develop competence in the foundations of the ISO 31000:2018 risk management standard.
